

NOTICE OF 2019 TAX YEAR PROPOSED PROPERTY TAX RATE FOR City of Cedar Park

A tax rate of \$0.448000 per \$100 valuation has been proposed by the governing body of City of Cedar Park. This rate exceeds the lower of the effective or rollback tax rate, and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate.

The governing body of City of Cedar Park proposes to use revenue attributable to the tax rate increase for the purpose of providing funding for essential city services such as additional public safety personnel, additional support for the library, park and facility improvements, and increases for staff compensation and benefits.

PROPOSED TAX RATE	\$0.448000 per \$100
PRECEDING YEAR'S TAX RATE	\$0.449000 per \$100
EFFECTIVE TAX RATE	\$0.436193 per \$100
ROLLBACK TAX RATE	\$0.448348 per \$100

The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue for City of Cedar Park from the same properties in both the 2018 tax year and the 2019 tax year.

The rollback tax rate is the highest tax rate that City of Cedar Park may adopt before voters are entitled to petition for an election to limit the rate that may be approved to the rollback rate.

CAN BE CALCULATED AS FOLLOWS:**

$$\text{property tax amount} = (\text{rate}) \times (\text{taxable value of your property}) / 100$$
