

ORDINANCE NO. CO25.17.03.09.E1

AN ORDINANCE APPROVING THE CITY OF CEDAR PARK CODE OF ORDINANCES CHAPTER 17 (TRAFFIC AND VEHICLES), ARTICLE 17.03 SPEED LIMITS, 17.03.005 CONSTRUCTION SPEED LIMITS, ESTABLISHING A CONSTRUCTION SPEED LIMIT OF 45 MILES PER HOUR ON RM 1431 BETWEEN COTTONWOOD CREEK TRAIL AND MARKET STREET; PROVIDING FOR SEVERABILITY; PROVIDING FOR A REPEALER; AND FINDING AND DETERMINING THAT THE MEETING AT WHICH THIS ORDINANCE IS PASSED WAS NOTICED AND IS OPEN TO THE PUBLIC AS REQUIRED BY LAW.

WHEREAS, the Texas Department of Transportation plans to widen RM 1431 from Cottonwood Creek Trail to Market Street to a six lane divided roadway; and

WHEREAS, the Texas Department of Transportation has requested that the speed limit within the project limits be reduced to 45 MPH for the duration of the project to increase safety for the public and construction workers; and

WHEREAS, the Code of Ordinances Chapter 17 Traffic and Vehicles, Article 17.03, Section 17.03.005 authorizes the City to adopt by separate ordinance a construction speed limit for roadway approved for construction which will supersede the speed limits shown in Section 17.03.004.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CEDAR PARK, TEXAS:

SECTION 1. Council hereby approves the temporary construction speed limit of 45 mph for RM 1431, between Cottonwood Creek Trail and Market Street, a distance of 1.18 miles as set forth in the Cedar Park Code of Ordinances Chapter 17 Traffic and Vehicles, Article 17.03, Section 17.03.005.

SECTION 2. The construction speed limit of 45 mph will take affect for the duration of the roadway construction and will expire when TxDOT has notified the City that construction has been completed.

SECTION 3. That the provisions of this ordinance are severable and the invalidity of any word, phrase or part of this ordinance shall not affect the validity or effectiveness of the remainder of the ordinance.

SECTION 4. That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 5. That it is hereby officially found and determined that the meetings at which this ordinance was introduced and passed were open to the public and that public notice of the time, place and purpose of said meetings were given all as required by law.
